

Dear Mr. Stuart:

Florida's Turnpike Enterprise (FTE) requests your processing and approval of this listed amendment to the FY 2021/22 – FY 2025/26 Transportation Improvement Program (TIP). This amendment is required because FTE had separated existing projects into projects of smaller sized individual lengths, to enhance the quality and efficiency of project management. Funding changes already occurred but these **project limit description changes** need to be reflected in the TIP. The purpose of these projects is to provide improvements that will enhance mobility and safety.

Project limits were changed for Turnpike's #437990-1 Resurfacing and for #437990-3 Roadside Improvements, as the limits of these projects now will only include the Turnpike's SR 821/SR 91 interchange ramps up to Miramar Parkway (MP 47.2 – 47.9, County MP 0.00 - .632).

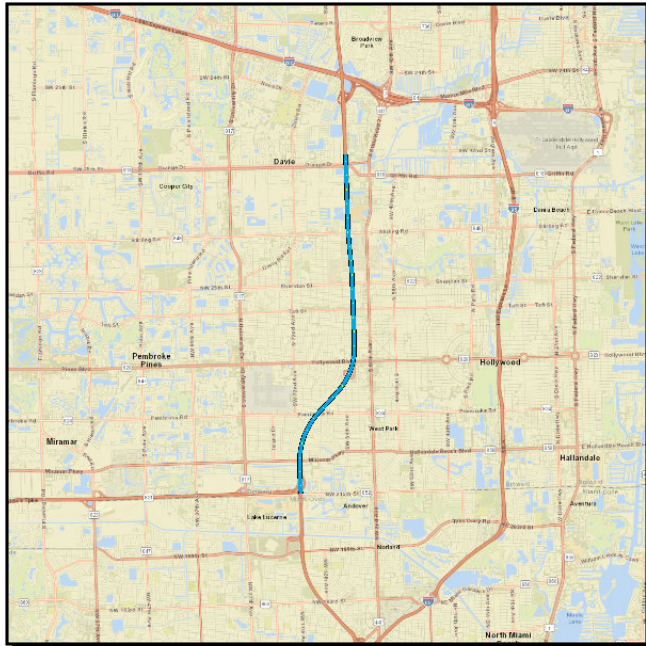

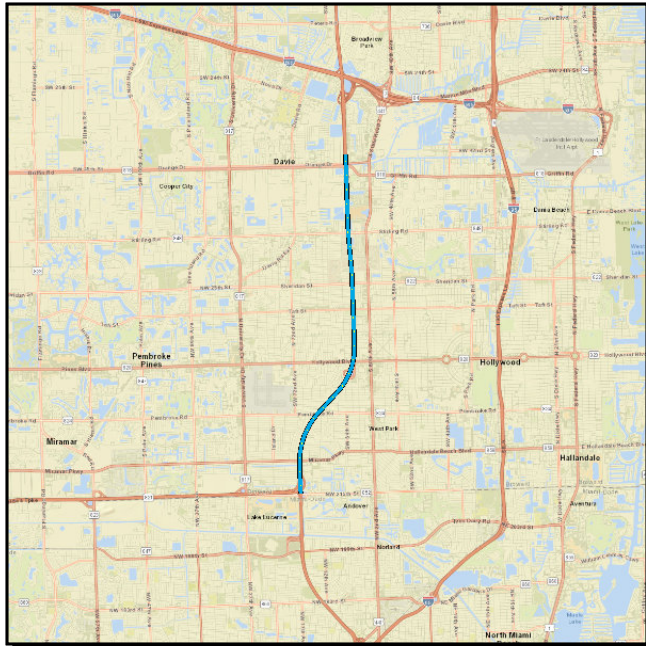

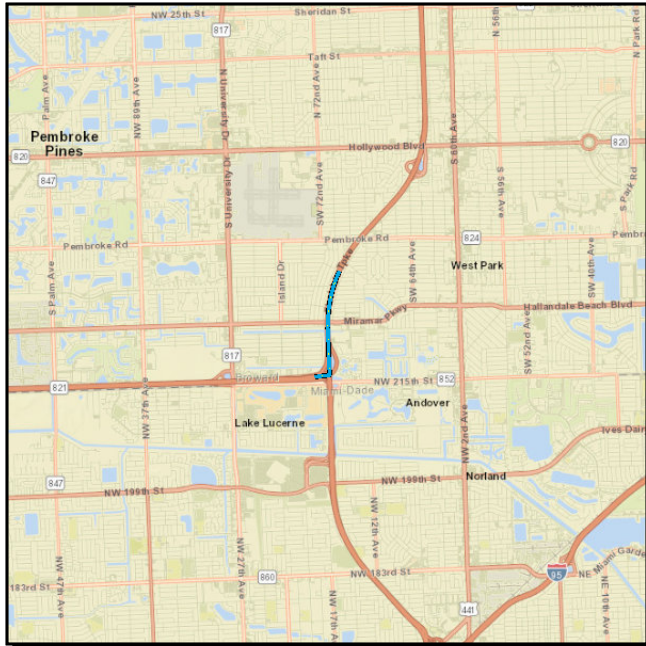
