

RESOLUTION NO. 2014-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO THE COMPLETE STREETS DESIGN GUIDELINES, AMENDING CHAPTER 25 OF THE BROWARD COUNTY ADMINISTRATIVE CODE; PROVIDING FOR NEW ROADWAY DESIGN ELEMENTS AS PART OF EXHIBIT 25.A, "MINIMUM STANDARDS APPLICABLE TO PUBLIC RIGHTS-OF-WAY UNDER BROWARD COUNTY JURISDICTION": PROVIDING FOR NEW DEFINITIONS: PROVIDING FOR NEW DEFINITIONS: PROVIDING FOR NEW COMPLETE STREETS GUIDELINES: PROVIDING FOR INCREASED ROADWAY SHOULDERS AND NEW ON-ROAD BICYCLE FACILITIES AND DESIGN CRITERIA, PROVIDING FOR TYPICAL SECTION FOR TRANSPORTATION COMPONENTS, APPENDIX E: AND PROVIDING FOR SEVERABLITY, INCLUSION IN THE BROWARD COUNTY ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

WHEREAS, on March 12, 2013, the Board of County Commissioners of Broward County, Florida ("the Board") approved recommendations presented by County staff at the February 19, 2013, Transportation Workshop, which included the establishment of a Broward County "Complete Streets Team" to review and make recommendations regarding the County's road planning, design and construction standards, and ordinances, and to draft the necessary amendments to create and implement Complete Street design guidelines; and

WHEREAS, as part of the March 12, 2013, Board meeting, the Board directed County staff to undertake all necessary steps to implement the approved recommendations and to draft proposed amendments to all appropriate documents to fully implement the Complete Street design guidelines; and

Complete Streets Project Evaluation Subcommittee Update

 Purpose: Measure the benefits and impacts
 Complete Streets projects have had on the community.
 Understand the value of the Complete Streets investment as it relates to each evaluation metric.

Broward Complete Streets Evaluation

Complete Streets Project Goal: improving walkability, accessibility and aesthetics, and reducing pollution, complete streets tend to improve livability (local environment quality and affordability).

Metric/Evaluation Question	Desired outcome	Measures	Quantification Method
Equitable Reach How many people were reached by implementation of complete streets on new or redeveloped road segment?	An increase in number of people reached through Complete Streets implementation projects. Additional credit or weight given to increasing options for disenfranchised communities.	Pre-Baseline: number of individuals living adjacent to corridor, description of the population	Measure length of segment and amount of individuals living adjacent to the project and able to connect within 2 miles to the project.
Acceptability What is the proportion of the reach engaging in multiple transportation options?	Cultural shift to multi-model.	Baseline & Post: proportion of individuals adjacent to the project driving, using transit, walking, and biking for nearby trips.	Sample survey residences and commercial properties adjacent to the corridor.
Accessibility How many destinations can more easily be accessed due to this Complete Streets project?	Connect communities to daily activities and services and increase possibility of human interactions and desolation. Improved user convenience and comfort.	Number of connections established or enhanced by complete streets project. Number of direct options from complete streets corridor project to nearest downtown center, medical facility, recreational or open space facility, academic institution or library, or other central business or civic center.	Primary: Map routes and nearby amenities pre and post. Secondary: Sample survey residences and commercial properties adjacent to the corridor.
